DESCRIPTION OF THE AWARD

The Wayne N. Ladouceur Award was established in order to preserve and honor Wayne's memory through encouraging and rewarding hourly employees who give of themselves to better the lives of others.

The annual Award recognizes a UH hourly employee from any UH department or facility who possesses and demonstrates—toward residents and clients—empathy, the ability to see beyond themselves, a love for life, generosity, and a strong drive to go above and beyond in providing the utmost in care for UH residents and clients.

Wayne Ladouceur served United Helpers residents for more than 30 years, in his own free time—spending countless hours with residents and tirelessly fundraising for UH. He often could be heard saying, "I get more out of spending time with the residents than they do." His desire to serve others was borne not from a feeling of obligation or guilt, but rather from his own compassion and his drive to serve others. Where he saw people in need—especially those who were lonely and whose families could not or would not visit—he knew, without being asked or directed, that he could make a tremendous difference. He personified the quality of giving generously to better the lives of others.

The Award is to be presented to the selected recipient in the early part of the calendar year, as near February 2 as possible, because that was Wayne's birthday.

The Award is made possible through a generous gift from Wayne's wife, Cheryl Ladouceur. Also, more than 80 individuals and families have made gifts. The Award is endowed, so that it will live forever at United Helpers.

ELIGIBILITY

A nominee is eligible for consideration if they:

- Are an hourly UH employee (that is, not on an annual salary)
- Are a current UH employee as of the time of nomination and as of the time period in which the nominations are being reviewed and the award is being presented
- Possess and demonstrate—toward residents and clients
 - o a strong drive to go above and beyond in providing the utmost in care
 - o generosity with their personal time
 - o the ability to see beyond their own needs
 - o empathy
 - o a love for life
